Dear Senator Daschle:

As members of Mental Health Liaison Group -- a coalition composed of family, consumer and provider organizations -- we are writing to express our endorsement of the "Patients' Bill of Rights Act of 1998" (S. 1890/H.R. 3605).

This measure provides essential protections for consumers in the private health insurance marketplace, building on reforms in Medicare and Medicaid and on recommendations by Members of Congress and the President's Commission on Consumer Protection & Quality in the Health Care Industry. For example, the legislation requires the development of quality criteria along with performance and clinical outcome measures for at-risk individuals and people with chronic and severe illnesses. If S. 1890 is passed, this provision will have an important positive impact on the health care provided to adults with severe mental illnesses, children with serious emotional disturbances and other people with significant mental disorders who are increasingly being served in managed care settings.

The bill reforms the utilization review process to require the use of trained personnel, assures fair appeals, guarantees access to emergency and urgent care services and holds health plans accountable for their decisions. In addition, where medically necessary, S. 1890 permits consumers to go outside of a closed drug formulary to access critically needed medications.

Given the history of insurance discrimination against people with mental disorders and the serious problems associated with the delivery of mental health care by HMOs, the "Patients' Bill of Rights Act" represents a critical step forward.
