Dear Madam Speaker and Leader Reid:

The undersigned national organizations in the Mental Health Liaison Group urge you to move forward and pass health care reform legislation in a timely fashion. We hail the bills approved by both houses and ask you to complete action now on improving access to affordable, quality health care services.

Improving the mental health of our nation is paramount. Mental disorders are the leading cause of disability in the United States for people ages 15 to 44. This population is also at a five times greater risk of a co-occurring medical condition, like heart disease, diabetes or cancer. Additionally, people with mental illnesses are two to three times more likely than other Americans to be uninsured. And tragically, adults with serious mental illnesses served in public mental health systems typically die 25 years earlier than the general population because of the high rate of co-occurring diseases.

Your leadership has been instrumental in moving two comprehensive health care reform bills through the legislative process. We depend on you now to enact a final health care reform bill to help millions of individuals, including uninsured and underinsured children and adults with mental disorders.

Thank you for advancing health care reform legislation that recognizes the mental and behavioral health needs of our nation. We are prepared to help you move health care reform to the President's desk for signature.
