Dear Senator Stabenow:

The undersigned members of the Mental Health Liaison Group are writing to express our strong support for the Mental Illness Chronic Care Improvement Act, S. 1136. Furthermore, we urge the Congress to include this important measure in any health care reform legislation that is enacted this year.

People with serious mental disorders treated in state mental health systems — a total exceeding three million persons — are confronting an emerging public health crisis. According to a recent study financed by the Substance Abuse and Mental Health Services Administration (SAMHSA), individuals with conditions like schizophrenia, bipolar disorder and major clinical depression served by public mental health agencies on average die 25 years sooner than other Americans. The same SAMHSA survey of eight states explains these shocking mortality data by documenting a sky high incidence of co-occurring chronic diseases among this low income disability population including cancer, diabetes, asthma, heart diseases and cardio-pulmonary conditions of all kinds. At the same time, clients of public mental health service agencies have little or no access to specialty medical services or even basic primary health care.

The Mental Illness Chronic Care Improvement Act represents the first large scale effort at the federal level to directly alleviate this crisis. By co-locating primary care capacity in Community Mental Health Centers (CMHCs) and other front line community-based mental health and substance abuse providers, the MICCI Act finances an integrated care model that facilitates access to needed medical services. We are also excited about the prevention and wellness activities in the legislation leading to better management of chronic conditions like hypertension, diabetes and diseases linked to smoking.

Senator Stabenow, thank you for your extraordinary leadership. The mental health community stands united and ready to assist you in enacting this critically important measure.
