Dear Chairwoman Murray, Ranking Member Burr, Subcommittee Chairman Casey, and Subcommittee Ranking Member Cassidy:

The Mental Health Liaison Group (MHLG), a coalition of national organizations representing consumers, families, mental health and addiction providers, advocates and other stakeholders committed to strengthening access to high-quality mental and behavioral health care, is writing to express our strong support for S.2779 the *Taskforce Recommending Improvements for Unaddressed Mental Perinatal & Postpartum Health (TRIUMPH) for New Moms Act.* The bipartisan *TRIUMPH for New Moms Act,* introduced in September by Sen. Hassan (D-NH) and Sen. Tillis (R-NC), will integrate and strategize federal resources to address the maternal mental health crisis. Currently, federal action on maternal mental health is disparate and uncoordinated across agencies and departments. *TRIUMPH* is a no-cost measure to reduce maternal mortality, prevent intergenerational harm, and mitigate impacts to the economy. We request that the bill be brought forward for consideration in the upcoming months.

Maternal mental health conditions, like postpartum depression, are serious illnesses that onset during pregnancy and the one year following childbirth. They are the most common pregnancy and postpartum complication, with 1 in 5 mothers suffering from a maternal mental health condition<sup>1</sup>. Despite this impact, 50% of these moms never receive treatment<sup>2</sup> – and when these illnesses go untreated, they cost the U.S. economy \$14.2 billion each year (or \$32,000 per mother-infant pair) in productivity loss, preterm births, and other health costs<sup>3</sup>.

Maternal mental health conditions are strongly related to substance use and maternal mortality, and suicide and overdose are the leading contributors to maternal death<sup>4</sup>. The COVID-19 pandemic has worsened maternal mental health, with pregnant and new mothers experiencing anxiety and depression at a three to four times higher rate than pre-pandemic.<sup>5</sup> Maternal mental health disorders have intergenerational effects, and increase the likelihood of preterm birth, low birthweight delivery, and infant

mortality; impair mother-infant bonding; and lead to behavioral, cognitive, and emotional impacts on the child<sup>6,7</sup>.

The timely and bipartisan *TRIUMPH for New Moms Act* would coalesce a federal interdepartmental task force across HHS, DOL, DoD, VA, and HUD to address maternal mental health conditions by closing gaps, eliminating duplication, and coordinating federal resources on maternal, child, and maternal mental health. The task force would also integrate maternal mental health into existing maternity care programs and issue strategic guidance to governors for implementation.

As the U.S. maternal mortality rate rises and millions of new moms struggle with postpartum depression, substance use, and other maternal mental health conditions, the nation needs a strategy for this crisis. In breaking down silos and bringing federal actors together, *TRIUMPH* will build that strategy based on best practices, effective programs, and innovative care models. To protect new moms and future generations, we urge the Committee to bring forward bipartisan, common-sense measures like S.2779 the *TRIUMPH* for New Moms Act for consideration this Fall.
